

CODE OF CONDUCT

- High standards of care for your children
- High expectations of ourselves and our staff
- A value system explained to staff, campers and families
- Boundaries clearly defined for campers and staff
- A strong partnership with our parents

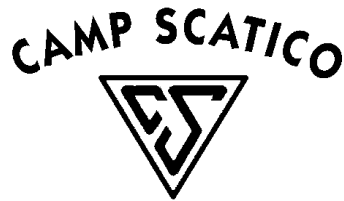
We know that you share our belief that camp is a great place to strengthen a youngster's sense of responsibility and personal code of ethics. We expect your children to:

- Serve as positive role models for the younger campers by respecting all members of the community as well as personal and camp property
- Be on their best behavior on trips out of camp and respect the rules and property of the places we visit
- Abide by our policy regarding "What to Bring and Not Bring to Camp" outlined on the reverse
- Understand that they are accountable for their actions and to accept the consequences for inappropriate behaviors

This code of ethics extends to the year-round use of cyberspace. Profiles, pictures, and messages on Internet vehicles, such as myspace.com and facebook.com, need to be bully-free zones and devoid of illegal, sexual, or other inappropriate content. Campers can be dismissed for offensive or inappropriate materials on personal pages or blogs.

There is **zero tolerance** of the following:

- Bringing into camp or using illegal drugs, alcohol, or cigarettes
- Leaving camp grounds without supervision or permission
- Physical, emotional, or verbal abuse of any member of the community
- Inappropriate sexual behavior
- Entering the camp of the opposite sex without permission

What is the Scatico Value System?

Appreciating and respecting the outdoors
Minimizing social competition
Approaching each day with a positive attitude
Respecting and accepting others
Giving your best effort

All our programs and policies are designed to implement this value system, from the dress code to the sports tournament schedule to full-camp events to package policies. We need parents to “buy-in” in order to nurture these values at camp.

WHAT CAN YOU BRING AND NOT BRING TO CAMP?

You can bring:

- Ipods and mp3 players...as long as they are used solely for music and not for videos or for other uses. Leave docking stations at home.
- Small, battery-operated fans for next to the bed
- Cameras not to be used for recording or playing moving images
- Blow dryers and other hair appliances are allowed, but their use is very restricted
- One or two plastic bins for underneath the bed
- On Opening Day, each camper can bring to their cabin a shoe-box-sized container of snacks (no drinks)

By leaving these items at home you are supporting our camp culture:

- Cell phones. Last summer we confiscated several cell phones from campers. This was upsetting to them.
- Other communication devices (pagers, beepers, walkie-talkies)
- Devices that record or play moving images, such as TVs, dvd players, PSPs, lap-tops, palm pilots, blackberries, game systems (game cube, playstation, etc.)
- Drawers or bins that do not fit underneath the bed
- Electrical appliances, such as fans and hot pots, and cooking equipment of any kind

new Bedazzled clothing or accessories to enhance the camp uniform. (Keep in mind the camp uniform is plain white tops and green shorts.)

new In order to moderate the style and amount of clothing and accessories, please limit Scatico-imprinted items to two or three and please only order from the camp catalog. (Keep in mind that we will provide two Scatico shirts to each camper.)

- Drinks of any kind, including bottled water and juice boxes
- Weapons or explosives of any kind: BB guns, super-soaker water guns, fireworks
- Personal sports equipment not listed on the "clothing list"
- First-aid medications, such as Tylenol or aspirin (the Health Center stocks these). It is against New York State law to keep medications (even over-the-counter ones) in cabins.
